### **Simon**

- No right-turn into Shepherds Hill Recreation Park. Amie advised the new U-turn facility further north
- Sturt Road/ Main South Road intersection traffic sequencing, green light time is short. The project team advised that Traffic management Centre will monitor this phase sequence
- Pools of water/ flood in bike lane between Sturt Road and Marion Road on the day of the Bridge move. – The project team advised that this will be monitored
- Main South Road Sturt Road line marking needs to more obvious.
   GWS to review and refresh the current line marking
- Signage near Birch Crescent/Sturt Rd intersection for pedestrian detours need review

#### Pam

- Concerns about the size of the Computer Equipment Room (CER) and is seeking more information on colour, fencing and landscaping.
- Franklin Avenue access arrangement were discussed in particular a concern that left turn in from South Road is too sharp. The following options were discussed for the junction of South Rd/Franklin Avenue including:
- Left out only available from Franklin Av
- Left in only available from Franklin Av
- Close the junction altogether

Pam agreed to discuss these options with her residents association group and outline their preference at the next meeting.

- Main South Road and Sturt Road, is it possible to have a stop sign instead of a giveway sign
- Bus stop 24 near Mimosa flooded query if drainage has been accommodated.

Amie advised this is only a temporary bus stop and will review the operation of this bus stop.
