## Material Loss or Damage

### 1. Insured Property

The Insurers will indemnify the Insured in accordance with the Basis of Settlement, against Damage to the Insured Property from a cause not specifically excluded, occurring at the site of the Insured Operations or at Offsite Storage or in transit within the Territorial Limits, in respect of:

- (a) Construction Plant and Equipment - during the Period of Insurance;
- (b) All other Insured Property - during the Construction Period.

### 2. Defects Liability (Extended Maintenance)

The Insurers will indemnify the Insured in accordance with the Basis of Settlement, against Damage to the Insured Property from a cause not specifically excluded, provided such Damage:

- (a) manifests itself during the Defects Liability Period; and
- (b) originates from:
  - (i) a cause arising during the Construction Period and at a Worksite; or
  - (ii) an act or omission of any of the Insured parties, or some other cause occurring in connection with the Insured party complying with the requirements of the Defects Liability Period provisions of the Contract.
