# PROPOSED BUCKLAND PARK COUNTRY TOWNSHIP

### Release of Environmental Impact Statement (EIS) for public comment

On 4 January 2007 the Minister for Urban Development and Planning declared that a proposal to develop a country township at Buckland Park would be assessed using the major development provisions of the *Development Act 1993* (declaration under Section 46(1)).

A Development Application for the proposed development was received from the Walker Corporation in June 2008. The application was referred to the independent Development Assessment Commission (DAC) for initial examination in accordance with the requirements of the Development Act. The DAC determined in August 2008 that the Walker Corporation should prepare a detailed Environmental Impact Statement (EIS) regarding the proposal, and issued formal Guidelines outlining the environmental, social and economic issues which the EIS had to address.

There is a proposal to close part of Legoe Road, Buckland Park for Stage 1 of this project. Under Section 6A and 7A of the *Roads (Opening and Closing) Act 1991*, there is the ability for the Governor to open or close roads as part of a Major Development assessment process. Road closures proposed in future stages of the project will undergo consultation as the development is progressed (if it is approved).

The Minister for Urban Development and Planning advises that the Walker Corporation has now prepared the EIS, which is being released for a 6 week public comment period from Monday 4 May 2009 until Monday 15 June 2009. The EIS can be obtained at the locations indicated below.
