## **Adoption of NCC 2019 Amendment 1 in South Australia**

An out of cycle amendment to NCC 2019 (Amendment 1) is scheduled for national adoption on 1 July 2020. A preview has been released by the Australian Building Codes Board (ABCB), which includes -

- a new provision in NCC Volume One regarding egress from early childhood centres;
- an update to the Governing Requirements for all Volumes to require labelling of aluminium composite cladding panels in accordance with Standards Australia Technical Specification 5344;
- clarification of the concession in NCC Volume One that permits the use of timber framing for low-rise Class 2 and 3 buildings;
- clarification in NCC Volume Two that anti-ponding board requirements only apply to roofs where sarking is installed;
- correction of minor errors; and
- a new provision to require that a process be followed to improve the quality of, and documentation of, Performance Solutions.

The defined term, 'complex buildings', which will be used to identify buildings that require additional oversight, will be going for further consultation with the intent to be incorporated in NCC 2022.

The provision was developed following lengthy consultation with stakeholders. It seeks to mandate the process in the ABCB's Development of Performance Solutions guideline to ensure that all building and plumbing Performance Solutions are developed and documented using an appropriate, nationally-consistent process.

A Consultation Regulation Impact Statement (RIS) was released for public consultation on 24 February 2020 and comments closed on 22 March 2020. The RIS analyses the marginal impacts of changing current practice for assessing and documenting Performance Solutions, as well as the administrative burden. The proposed changes published in the Consultation RIS relating to A2.2 (4) Performance Solution and included in the NCC 2019 Amendment 1 will not take effect in South Australia until 1 July 2021. The ABCB website contains additional information about the process for the development of Performance Solutions.
