I refer to your applications to the Office of the Minister for Transport, Infrastructure and Local Government, Minister for Planning made under the *Freedom of Information Act 1991* (the Act) which were received 13 September 2019.

You have requested access to:

“Copies of any and all documents (including but not limited to hard copy or electronic briefings, minutes, reports, emails, letters, meeting agendas, diary entries and any other correspondence) between the Minister and/or Minister’s Office staff and the Premier and/or the Premier’s Office in regard to any FOI, 18/3/18-11/9/18 and 12/9/18-11/3/19 and 12/3/19-12/9/19.”

A search of documents held by the Office of the Minister for Transport, Infrastructure and Local Government, Minister for Planning was undertaken. I wish to advise that two documents have been identified within the scope of your request.

I have determined to release document 1 and partially release document 2 to remove personal affairs in accordance with Clause 6(1):

6 – Documents affecting personal affairs

(1) A document is an exempt document if it contains matter the disclosure of which would involve the unreasonable disclosure of information concerning the personal affairs of any person (living or dead).

Document 1 includes attachments that were consulted on as part of the mandatory FOI consultation process and have not been included.
