Hi All,

I last wrote to you on 30 March 2021, providing an update on the process of the move to the Future Across Government Facilities Management Arrangement (AGFMA), being the new model for the management of facilities services in South Australia, to ensure improvements to safety, efficiency and effectiveness of the maintenance and management of government assets.

The evaluation of tenders from the four shortlisted bidders - BGIS, Jones Lang LaSalle, Spotless and Ventia – as part of the provision of the Future AGFMA is progressing well, and we expect the Government to be in a position to announce the successful Future Facilities Management Service Providers (FMSPs) in very late June or early to mid-July 2021.

We will advise you of the outcome of this process via email shortly after the announcement of the successful FMSPs, and it is expected they will reach out to contractors of the existing AGFMA (current DIT - Facilities Services and Spotless contractors) including Small to Medium Enterprises (SME's) in the weeks after that announcement.

Introductory Information Forums, coordinated by the Future AGFMA Team and attended by the successful future FMSPs will be held from July/August 2021. This will include sessions in both regional SA and metropolitan Adelaide. The FMSPs will be required to develop and maintain strong relationships with contractors including SMEs throughout the term of the contract and the Information Forums will be an important base to ensure required on-boarding activities including pre-qualification processes, systems training and other required assistance is provided, to ensure a smooth transition to the Future AGFMA service commencement date of 1 December 2021.

To ensure you are contacted moving forward about any Information Forums, I again encourage you, in line with my previous communication in <u>March 2021</u>, to register on the Future AGFMA website, if you haven't already. This will allow us to share your details with the successful FMSPs. Please note: if you have previously registered through either the Future AGFMA website or the Industry Capability Network (ICN) process then no further action is required, as we will already have details, and your permission to pass on your details to the successful FMSPs.

The Future AGFMA Team remain committed to strong local contractor involvement in the Future AGFMA. You are aware of the "What We've Heard" Report and the "What We're Actioning" Report. The 3<sup>rd</sup> report from that work is an Outcomes Report, connecting your feedback with contractual requirements for the Future AGFMA. As the Outcomes Report directly relates to the future FMSP contract terms, the release of this 3<sup>rd</sup> report will be timed to coincide with the announcement of the successful FMSPs.
