Some applications require public notification. Members of the public can provide comment in relation to developments on public notice by submitting a written representation.

Prepare your representation

Your representation must be submitted through an approved form which can be completed digitally through the [PlanSA Notified Developments Current public notices](#) or manually on the [Representation on Application](#) form available on the [PlanSA](#) portal.

A representation form is available for each application that is on public notification.

For a representation to be valid it must:

- be in writing
- include your name and address
- set out the particular reasons why planning consent should be granted or refused
- comment only on the performance-based elements of the proposal.

Letter advising owner/occupier of a proposed development

You will be advised by letter if you are an adjoining owner/occupier potentially affected by a development proposal that is subject to public notification. This letter may arrive in the post – or via email if you have provided your email to the relevant authority for public notification purposes.

This letter will outline when the public notification will commence, the location of the proposed development, the nature of development and where you can view the application documentation – i.e. the online **Have your say** page, or at the relevant authority's principal office.

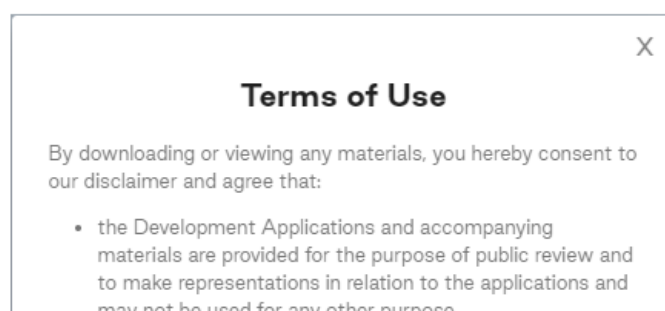
