On-boarding

We are tracking this closely and urge those who are still needing to lodge the pricing schedules or employee information in Ventia's Rapid Global system to do so with some urgency to be ready to commence with Ventia on 1 December 2021.

Ventia Training

Ventia has frequently communicated the importance that all key representatives have access to and are trained in the new Ventia system as soon as possible. Subcontractor Registration and relevant Ventia training needs to be completed before starting any work on the Future AGFMA.

For the training, you have the ability to assign employees to either an 'admin' or 'trades' role so that your employees can complete specific training modules as required.
