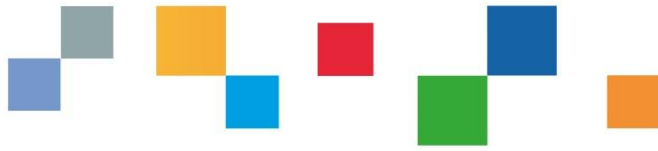

What to call the Future AGFMA when it goes live?

In all our correspondence about the AGFMA we have been referring to the **Existing AGFMA** (which involves Spotless and DIT Facilities Services), and the **Future AGFMA** (which involves Ventia).

Once we go live from 1 December 2021, you will start to see a change of language, in that we will refer to the **Former AGFMA**, and the **AGFMA**. The word 'Future' will be removed from correspondence moving forward.
