

Coast Park Stage One

Semaphore Park to West Lakes Shore

Construction Works

Construction of Stage One of Coast Park (located between Third Avenue, Semaphore Park and the northern edge of the Wara Wayingga-Tennyson Dunes Conservation Reserve at West Lakes Shore) will begin on Wednesday 17 May 2023. Work is expected to be complete in late 2023, weather permitting.

A site office has been established at Mirani Court and this compound will be used for the duration of the project. Site access will be via Mirani Court, Sandpiper Place and Third Avenue.

Preparation of the area required to construct the path

Preparatory works will first be undertaken. These activities will commence from the northern edge of Tennyson Dunes Conservation Reserve progressing towards Mirani Court, then continue between Mirani Court towards Third Avenue.

Roots extending into the construction area, from the **introduced Casuarina trees**, will be cut and treated prior to construction of the path, in line with specialist advice. Some Casuarina trees not required for important dune stabilisation may be removed.

Residents who have planted vegetation along the dunes edge are encouraged to salvage these plants prior to construction. This vegetation will be removed as part of the site preparation works.

Private irrigation lines on the public reserve will be cut and capped by experienced irrigation specialists. New irrigation lines will be installed for project landscaping.

Path construction and landscaping

Construction of the path will occur in two construction areas and be progressively opened once completed. Work will generally be undertaken between 7am and 5pm Monday to Friday, and Saturdays from 8am to 2pm, when required.

Please refer to the map for further information on staging and timing of construction. Landscaping works will be undertaken progressively as the path is completed.

Some temporary pedestrian detours may be in place around the work sites and pedestrians are advised to follow directional signage. Every effort will be made to minimise impacts to the community.

Advance notice of works will be provided to properties within close proximity to the construction area.

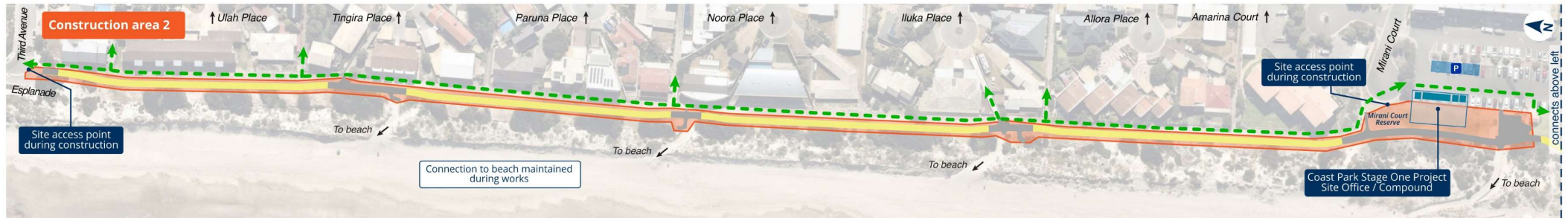
