



Crafers Park 'n' Ride

Project Update February

The Project

As part of the Government's \$19 million commitment to improve transport to support growth in Mount Barker and the Adelaide Hills, the South Australian Government has committed \$6 million to deliver additional parking at the Crafers Park 'n' Ride.

The existing Crafers Park 'n' Ride is the closest Park 'n' Ride facility to the city in the Adelaide Hills region, with 39 car spaces.

We will be increasing the number of car parks to more than 120 by delivering a new Park 'n' Ride facility to the southeast of the existing one.

Park 'n' Ride facilities allow people to park cars or bikes and transfer to public transport to complete their journey. These facilities reduce reliance on private vehicles, also reducing congestion and environmental impacts.

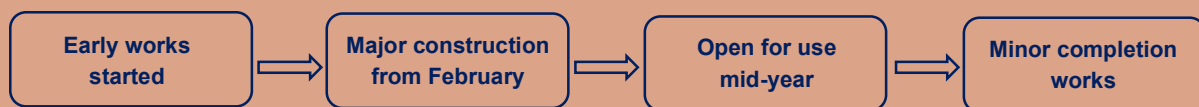
Project Design

We have considered community feedback when preparing the final project design. The new site will be built to the southeast of the existing Crafers Park 'n' Ride, next to the Crafers off ramp (westbound) and the South Eastern Freeway and will include:

- 85 new car parking spaces, including two accessible bays and motorcycle parking;
- lighting and CCTV to increase safety and security;
- new paths, including a shared use path; and
- landscaping.

Timing and Key Activities 2024



Early Works and Site Setup

We have established the main site compound southwest of the project site.

Early works started on 5 February 2024, and the new Park 'n' Ride facility is expected to be open for use in mid-2024, weather permitting.

Works Hours

Standard work hours for the project are 7am to 5pm Monday to Friday. Some weekend works may be required.

If early morning works or night works are needed, we will provide advance notice to nearby residents and businesses.

Impacts during Construction

There will be changes to traffic conditions near the work area to keep everyone safe. Please take care when driving through the area and follow signage and traffic management directions while works are in progress.

We may need to use additional lighting to safely undertake the works. To minimise spill from light towers, we will keep the extra light to the minimum required for safe access and works and direct light towers away from houses.

During the works, there will be some noise from time to time, but we'll do our best to keep the noise to a minimum.

Please expect to see:

- lane and speed restrictions;
- traffic controllers and their vehicles;
- wayfinding and temporary detour signage;
- temporary fencing; and
- work crews, vehicles, trucks and machinery accessing the work zones and undertaking works.

Construction and site vehicles will avoid using local streets and existing Park 'n' Ride parking wherever possible.

Vegetation Management

We have carefully designed and staged the project and, where possible, adopted options to minimise impacts on trees and other vegetation. Removal of some vegetation is, however, necessary to construct the new facility.

Approval to remove vegetation on site has been granted by the Native Vegetation Council.

New trees will be planted at the site as part of project landscaping.

Pedestrians and Cyclists

Once the project is completed and the new facility is open for use, pedestrians and cyclists will use the existing footpaths and shared use paths along Waverly Ridge Road to move between the Park 'n' Ride facilities and bus stops.

Existing Adelaide Metro bus services will operate as usual during construction.
